



YOUR AGREEMENT FOR THE BETH EL ISRAEL TOUR OCTOBER/NOVEMBER 2027:

PAYMENTS: All reservations forms must be accompanied by a check deposit of \$500 per person. If paying deposit by credit card a \$20 fee applies. Final payment is due by June 30, 2027. Review penalty schedule for details. Checks are made payable to Brit Olom Tours, Inc. Final payment can be made by credit card. Add \$200 per person credit card fee for double occupancy or add \$275 for single occupancy for final payment by credit card.

LAND ARRANGEMENTS: Sightseeing and meals are included as per itinerary. Package is based on double occupancy sharing a twin-bedded room with private facilities including service charges and taxes. Single rooms are available at additional cost. Diesenhau Unitours/Brit Olom Tours, Inc. reserves the right to substitute hotels of like category or better according to availability and circumstances beyond our control. Itinerary may be experienced in a different order and some sites may be omitted due to time constraints. Please note that the itinerary is also subject to change based on time, weather, security, and other considerations.

AIR ARRANGEMENTS: We recommend the El Al flight schedule from Miami for this tour but you are welcome to use any carrier. We are not holding any airline seats for the group. If your flight arrives in the morning, you may store your luggage until your room is ready for check-in at 3:00pm.

TRANSFERS: Transfers are on a seat in coach basis on the tour dates unless otherwise specified and are included for the El Al flight schedule from Miami. Passengers arriving and/or departing independently may be responsible for their own transfers.

NOT INCLUDED: Passport and visa fees, travel insurance (strongly recommended), tips to guide and driver, meals and touring not listed in the itinerary, expenses of a personal nature.

OPTIONAL TOURS: Optional tours will be reserved and paid for separately by each participant and are not included in the tour price. Diesenhau Unitours/Brit Olom Tours, Inc. are not responsible for any aspect of optional tours booked independently.

MINIMUM PARTICIPANTS: A minimum of 10 participants is required for this departure. In the event the required number has not been reached, the tour can be cancelled. Should this occur, your deposit payment will be refunded in full less any credit card fees.

INSURANCE: Travel insurance is not included in the tour package. It is highly recommended to purchase insurance for trip cancellation, medical emergency and baggage.

DOCUMENTS AND HEALTH: A passport valid for at least 6 months from the completion of your trip is required for all participants. There is no visa requirement for USA citizens. Starting from January 2025, visitors from visa-exempt countries are required to obtain an ETA-IL(Electronic Travel Authorization) to enter the state of Israel. An approved ETA-IL, indicates that you are allowed to travel to Israel and stay for up to 90 days per visit. All travelers to Israel must have a valid visa or an ETA-IL approval before they start their journey.

Other nationals must contact the appropriate consulate for travel requirements. Participants take full responsibility for their health in general as well as any health and travel advisements. You are responsible to know and adhere to all current protocols for your tour.

BAGGAGE: Baggage is limited to 1 piece of luggage per person, the combined total dimensions of the bag may not be larger than 62 includes or exceed 50 pounds. One piece of carry-on luggage is allowed. All excess baggage charges will be collected at the airport. Baggage is at "own risk" throughout the tour. The tour operator and Brit Olom Tours, Inc. are not responsible for lost or damaged baggage. Baggage insurance is recommended.

CANCELLATION FEES: All cancellations must be received in writing by the dates below.

Penalty Schedule:

Cancellation notices received in writing by June 29, 2027: \$500 per person administrative fee.

Cancellation notices received in writing from June 30, 2027 and after: 100% penalty

Credit card fees are always non-refundable.

PRE AND POST: Participants will be responsible for their own transportation and accommodations if they want a pre or post stay in Israel. Brit Olom Tours Inc. is happy to assist with those arrangements which will be in addition to the tour pricing.

We can also curate pre or post arrangements in other countries if desired.

RESPONSIBILITY: Diesenhaus Unitours/Brit Olom Tours, Inc. are acting solely as an intermediary agent for the travel suppliers providing means of transportation, hotel and/or all related services being purchased (the "Third Party Providers"). Diesenhaus Unitours/Brit Olom Tours, Inc.. therefore, shall not be responsible for an injury, illness or loss involved with travel resulting from detention, annoyance, delays, quarantine, strikes, thefts, pilferage, force majeure, diseases, mechanical difficulties, failure of means of transportation to arrive or depart as schedules, civil disturbances, terrorism, government restrictions or regulations and discrepancies or changes in transportation or hotel services or any other matter or event over which the Diesenhaus Unitours/Brit Olom Tours, Inc.. has no control or for any state of quality, hygiene, political stability, cuisine, sanitation facilities, cleanliness, telecommunications facilities, methods of conducting business, emergency medical evacuation, treatment or medical services existing at any travel destination. By embarking upon his/her travel, the passenger voluntarily assumes all risks involved in such travel whether expected or unexpected. The tour registration shall constitute consent by the purchaser and/or passenger to the foregoing conditions. All itinerary and tickets are also subject to such additional terms and conditions as the Third Party Providers may impose. Finally, Diesenhaus Unitours /Brit Olom Tours, Inc. shall not be liable for any funds received from the purchaser and/or passenger and paid over to any Third Party Provider which subsequently becomes insolvent or files any bankruptcy or similar proceedings or fails to deliver services.

SPECIAL NOTE: Delays, cancellations and overbooking by participating Third Party Providers may occur on air flights and land reservations. While the Diesenhaus Unitours/Brit Olom Tours, Inc. will do their utmost to avoid these inconveniences, they shall not be liable for or responsible for the acts or omissions of such Third-Party Providers.

Diesenhaus Unitours/Brit Olom Tours, Inc. reserve the right to cancel any tour, substitute hotels and make such alterations in tour itineraries as may be necessary or desirable for the convenience of the parties and the proper conducting of the tour and to decline to accept or retain any person as a member of any tour. We reserve the right to refuse the application of anyone and/or expel from any trip/tour members whose conduct is incompatible with the interest of the group.

Any additional costs, if necessary, shall be the passenger's responsibility. In addition, Diesenhaus Unitours/Brit Olom Tours, Inc. may cancel any tour prior to departure. In such case, a full refund of all payments will constitute full settlement with the passenger and/or purchaser of the tour. All disputes arising under, in connection with, or incident to this agreement shall be litigated, if at all, in the tour operator's home country of Israel, and not in any other country. All claims against Diesenhaus Unitours/Brit Olom Tours, Inc must be brought to their attention in writing within 30 days after return of the trip with the understanding that all suits will be brought only in Israel. Deposit for the tour by the purchaser or passenger shall constitute consent to the above terms as well as an agreement on his/her part to convey the contents hereto to his/her travel companions or group members.

Brit Olom Tours Inc. may display a testimonial by or photo or video of tour participants on their website or other promotional materials or social media. This tour involves some walking and climbing of stairs.
